- 14. Transfer of risk: As per ICC Incoterms 2010
- Liquidated Damages: 0.5% of delayed portion per week up to a maximum of 5% of delayed portion with one week grace period.

- 16. Warranty: Shall be valid 12 months from commissioning or 18 months after delivery to Egypt whichever comes sooner.
- 17. Tax and Duty: All tax, duty and custom outside China shall be borne by the Buyer.
- 18. Other general Terms and Conditions:
 - 1). Quality/quantity discrepancy: In case of quality discrepancy, claim should be filed by the Buyer within 90 days after the arrival of the goods at port of destination; while for the Quantity discrepancy claim should be filed by the Buyer within 60 days after the arrival of the goods at port of destination. It is understood that the Seller shall not be liable for any discrepancy of the goods shipped due to causes for which the insurance Co. Shipping Co. other transportation organization or Post Office are liable.
 - 2). The Seller shall not be hold liable for failure or delay in delivery of the entire lot or a portion of the goods under this contract in consequence of any Force Majeure incidents.
 - 3). All disputes arising from the execution of, or in connection with this contract, shall be settled through friendly negotiation. In case no settlement can be reached, the case shall then be submitted to the China International Economic and Trade Arbitration Commission in Beijing, for arbitration in accordance with its Rules of Procedure. The arbitration fee shall be borne by the losing party, and the arbitration award is final and binding upon both parties.
 - 4). The Buyer is requested to sign and return one copy of this contract immediately after receipt of the same. Objection if any should be raised by the Buyer within five days after the receipt of this contract. In the absence of which it is understood that the Buyer has accepted the terms and conditions of this contract.
 - 5). The Buyer expressly represents and warrants that (i) the Buyer is not a Restricted Person and is not controlled by or acting as an agent of any such Restricted Person; and (ii) any goods, services or technologies received from the Seller in connection with this Contract shall not be resold or transferred to any Restricted Person. For purposes of this Clause, a "Restricted Person" is any individual or entity who is subject to the Unite Nations, U.S. or other relevant authority's trade sanctions or other restrictions, or with whom trade or financial dealings and transactions by the Seller and/or its affiliates are prohibited or restricted. The Seller shall be entitled for indemnifications from the Buyer and reserves the right to seek any reachable remedies if the Buyer breaches its above representations and warranties.
